Methods for Containment and Clean Up Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Prevent product from entering drains. Keep in suitable, closed containers for disposal. Do not flush into surface water or sanitary sewer system. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

7. Handling and storage

Handling Do not breathe mist/vapors/spray. Do not get in eyes, on skin, or on clothing. Handle product only in closed system or provide appropriate exhaust ventilation.
